With this goal in mind, we utilize a Multi-Disciplinary Team (MDT) approach to include Law Enforcement, Prosecutors, Social Services, Mental Health and Medical Professionals, while respecting and honoring our culturally diverse clientele within the community. Such an interagency effort facilitates the appropriate and consistent detection of and response to child abuse in our community.
