The Crime Victims Reparations Fund is regarded as the "payer of last resort." It is a secondary source that pays for certain outof-pocket expenses related to the crime that the victim has no other way to pay. Other sources that have to pay first include:
HMO/health insurance; Disability insurance/life insurance;
Vacation time, sick leave or other types of leave paid by an employer; Worker's compensation benefits; Social security; and Medicare or Medicaid. The staff of the Crime Victims
Reparations Program will work with victims and claimants to make sure all available resources, including the fund, work in the best interest of victims. Victims/claimants of a sexualrelated offense may or may not file with their insurance.

A victim of a federal crime may file a complaint against any employee of the Department of Justice who violated or failed to provide the rights established under the Crime Victims' Rights Act of 2004, 18 U.S.C. § 3771. The Department of Justice has established the Office of the Victims' Rights Ombudsman to receive and investigate complaints filed by crime victims against its employees, and has implemented Procedures to Promote Compliance with Crime Victims' Rights Obligations.

The EEOC is responsible for enforcing federal laws that make it illegal to discriminate against a job applicant or an employee because of the person's race, color, religion, sex (including pregnancy, transgender status, and sexual orientation), national origin, age, disability or genetic information. The EEOC has the authority to investigate charges of discrimination against employers who are covered by the law. Our role in an investigation is to fairly and accurately assess the allegations in the charge and then make a finding. If we find that discrimination has occurred, we will try to settle the charge. If we aren't successful, we have the authority to file a lawsuit to protect the rights of individuals and the interests of the public and litigate a small percentage of these cases. We also work to prevent discrimination before it occurs through outreach, education, and technical assistance programs. The EEOC provides leadership and guidance to federal agencies on all aspects of the federal government's equal employment opportunity program.

I use the word "ally" loosely because I find it overused and often abused by those who label themselves "allies." Despite its current misuse, using a different word would only cause confusion. As you read through this guide, be aware that your definition of "ally" may not be the same as the definition I'll introduce you to.

The ACP provides relocated victims of abuse, sexual assault or stalking with a substitute address to use in place of their actual address when they apply for or receive state or local government services (e.g., driver's license, voter registration, public school records, etc.). The goal of the ACP is to prevent an assailant or potential assailant from finding the location of a victim through the state's public records. The ACP is not a witness protection program and does not assist participants in obtaining new names, social security numbers or in relocating to a new residence. The ACP does not provide legal advice to the participant, but acts as the agent of a program participant for purposes of service of process and forwarding all first-class, certified or registered mail.

We draw upon the civil rights law Title IX as an alternative to the criminal legal system one that is more just and responsive to the educational, emotional, financial, and stigmatic harms of violence. We support the choices survivors make and recognize that these choices are particularly difficult because our laws and communities offer a severely limited set of options for survivors. Given the tremendous flaws and violence of the criminal justice system, we celebrate Title IX's potential to create effective anti-carceral responses to serious harms while recognizing that this promise has not yet been realized.

The Louisiana Protective Order Registry is a statewide repository of court orders issued to prohibit domestic abuse, dating violence, stalking, and sexual assault. The registry was established by legislative act in 1997, for the purpose of enhancing court-ordered protections for victims and their minor children, and to aid law enforcement, prosecutors and the courts in handling cases involving intimate partner violence. LPOR is not a public access database. From this site, you can view and download legal forms and software programs developed by LPOR to assist those who fill out forms on a regular basis. A compilation of Louisiana and federal laws related to domestic violence, including a table of relevant cases, can be viewed and downloaded from this site. Our foundation was born out of a family tragedy: on November 27, 2018, Nadia's mother was murdered during the commission of a carjacking in front of Nadia's home in Gentilly. Nadia's husband Kristian suffered a traumatic brain injury while attempting to stop the crime; her mother died on her way to the hospital. It was during her long road of recovery, it became clear to Nadia and her family that they were not the only individuals who had fallen victim to the vicious cycle of trauma present in New Orleans. Learning of the trauma the three defendants in her mother's murder trial endured, without proper mitigation, compelled Nadia to launch Love Your Neighbor NOLA. Comparing and contrasting their stories of growing up, she began to wonder if a solution to the cycle of violence began in the home. She came to realize there are violence-ridden communities where trauma begets trauma, a cycle caused by a lack of access to resources, such as mental health care, and support systems. Bearing these observations in mind, Love Your Neighbor NOLA was created to be a refuge and resource for parents and children alike.
